ACCEPTABLE

- 1) EXHAUST IS AIMED AWAY OR PARALLEL TO STRUCTURE.
- 2) EXHAUST IS NOT DIRECTED AT PLAY AREAS, PATIOS OR OTHER AREAS WHERE PEOPLE CONGREGATE.
- 3) THE NEAREST WINDOW, VENT, DOOR OR SIMILAR STRUCTURE OPENING IS AT LEAST 5 FEET FROM THE EXHAUST END OF THE SET.
- 4) SET HAS PROPER OFFSET FROM STRUCTURE.
- 5) WINDOWS & DOORS ON ADJACENT WALLS ARE CLOSED.
- 6) FURNACE AND OTHER SIMILAR INTAKES ARE AT LEAST 10 FEET FROM EXHAUST END OF SET.
- 7) WEED BARRIER AND 3 INCH THICK GRAVEL BASE OR CONCRETE PAD LOCATED TO PREVENT GRASS & WEEDS FROM GROWING TOO CLOSE TO THE SET.
- 8) NO PLANTS, SHRUBS OR OTHER COMBUSTIBLES ALLOWED IN CLEARANCE AREA. (MINIMUM 4FT FROM EXHAUST END)
- 9) REFER TO OWNERS MANUAL FOR OTHER INSTALLATION CONSTRAINTS.
- 10) NO PLANTS, SHRUBS, OR OTHER COMBUSTIBLES ALLOWED WITHIN 18" OF THE AIR INTAKE

NOTE:  
 1) THE REQUIRED DISTANCE FROM A STRUCTURE IS DEPENDENT ON STATE AND LOCAL CODES. NFPA37 STANDARDS FOR THE INSTALLATION AND USE OF STATIONARY COMBUSTION ENGINES AND GAS TURBINES.
